#### Discussion:

VICE CHAIRMAN RIC HOLDEN: The critical element, when you're talking about harvesting buffalo, is that the Department of Agriculture has a plan to try to take care of this situation. They are negotiating with the federal government and Yellowstone National Park. At this point, it wouldn't be smart for us to open this up for public hunting until we resolve the bigger problem, which is brucellosis in Yellowstone Park. Once we get

that under control, then it may be okay to look at the issue of public hunting of bison. Until then, it's critical that we let the Department proceed without hampering their negotiations.

CHAIRMAN MESAROS: I would comment that current law allows for public hunting in the future once they identify a disease free herd.
