BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Purpose. The purpose of this act is to have created and placed within the state capitol a bust or statue in the likeness of the late Burton K. Wheeler, United States Senator from Montana. For this purpose the Montana arts council is authorized to accept grants or donations from public or private sources in addition to the funds herein appropriated. The department of administration is directed to locate the statue or bust, when completed, in a suitable site within the capitol building or grounds.

Section 2. There is appropriated from the general fund to the Montana arts council the sum of twenty thousand dollars (\$20,000) to commission and acquire a statue or bust of the late Burton K. Wheeler.
