 16 fifteenth day of April. Any nontenure teacher who does not  
 17 receive notice of reelection or termination shall be  
 18 automatically reelected for the ensuing school fiscal year.  
 19 Any nontenure teacher who receives notification of his  
 20 reelection for the ensuing school fiscal year shall provide  
 21 the trustees with his written acceptance of the conditions  
 22 of such reelection within twenty (20) days after the receipt  
 23 of the notice of reelection. Failure to so notify the  
 24 trustees within twenty (20) days may be considered  
 25 nonacceptance of the tendered position. The provisions of

1 this section shall not apply to cases in which a nontenure  
 2 teacher is terminated when the financial condition of the  
 3 school district requires a reduction in the number of  
 4 teachers employed and the reason for the termination is to
