10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11 Section 1. Department to distribute local government 12 study funds -- schedule of disbursement. On or before August 13 1 of each fiscal year, the department of intergovernmental 14 relations shall distribute any funds appropriated to the 15 department for the support of local government study 16 commissions to the treasurers of incorporated municipalities 17 and counties according to the following table:

3	Section 2. Applications for additional funds. (1) The	
4	department of intergovernmental relations shall establish	
5	procedures by which the local government study commission of	
6	counties with a population of less than two thousand (2,000)	
7	may apply for additional state funds up to a total of six	
8	thousand dollars (\$6,000) in fiscal year 1976 and three	
9	thousand dollars (\$3,000) in fiscal year 1977.	

10 (2) The application for additional funds shall be in 11 the form prescribed by the department of intergovernmental 12 relations and shall contain, in addition to any other 13 information required by the department of intergovernmental 14 relations, a statement showing the county appropriation to 15 the study commission which must be in excess of one thousand 16 dollars (\$1,000) for fiscal year 1976 or five hundred 17 dollars (\$500) for fiscal year 1977 and a proposed budget 18 showing the manner in which the funds applied for will be 19 expended.

(3) No application may be approved for an amount that,
together with the state grant provided for in section 1,
exceeds the total appropriated by the county for a study
commission.
