Hanne BILL NO. 690 1 INTRODUCED BY 2 3 A BILL FOR AN ACT ENTITLED: "AN ACT TO APPROPRIATE MONEY 4

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10 Section 1. Definitions. For the purposes of this act, unless otherwise stated: (1) "Agency" means all state 11 12 offices, departments, divisions, boards, commissions. 13 councils, committees, institutions, units of the university system, and other entities or instrumentalities of the 14 15 executive branch, offices of the legislative branch, or 16 office of the judicial branch of state government.

17 (2) "Capital project" means acquisition of land or 18 improvements, planning, capital construction, renovation, 19 furnishing and major repair projects authorized in this act. 20 (3) "Approved budget amendment" means approval by the 21 budget director of a request submitted through the 22 construction and maintenance division of the department of 23 administration to:

24 (a) obtain financing for a new or expanded project25 from funds which were not available for consideration by the

l legislature, but which have become available; or

2 (b) transfer excess funds appropriated to a capital
3 project within an agency to increase the appropriations of
4 another capital project within that agency.

5 Section 2. No new capital project may be established 6 and no existing capital project may be expanded beyond the 7 scope of the project as approved by the legislature in the 8 1977 biennial budget unless the new capital project or the 9 capital project expansion is authorized by an approved 10 budget amendment.

Section 3. If a capital project is jointly financed by 11 12 an appropriation or appropriations from state sources as 13 well as by appropriations from other sources, the funds 14 provided by appropriation from state sources shall be 15 decreased by the amount that the funds received from other 16 sources exceeds the amount from other sources appropriated 17 by the legislature in the 1977 biennial budget, provided 18 that: (1) the decrease does not jeopardize the receipt of the funds to be received from other sources; and 19

(2) the additional funds are to be expended for a new
or expanded project approved by the budget director upon
request submitted to him through the construction and
maintenance division of the department of administration.

24 Section 4. When an agency receives federal funds as a 25 reimbursement for the cost of administering a federal program and this cost was financed by an appropriation from
 state funds, the cost must be transferred from the state
 fund to the federal and private revenue fund unless usage of
 the federal funds is restricted by federal provisions.

5 Section 5. If any section, subsection, sentence, 6 clause, or phrase of this act is for any reason held 7 unconstitutional or void, such decision shall not affect the 8 validity of the remaining portions of this act.

9 Section 6. The following money is appropriated from 10 indicated funds and accounts to the director, department of 11 administration, for the biennium ending June 30, 1977, for 12 the indicated capital projects.
