10 Section 1. Section 84-603, R.C.M. 1947, is amended to
11 read as follows:

12 "84-603. Application for reduction in valuations. No
13 reduction must be made in the valuation of property unless
14 the party affected thereby, or his agent, makes and files
15 with the county tax appeal board on or before the ~~1st-day-of~~
16 August, third Monday of July, a written application therefor.
17 Said application shall state the post-office address of the
18 applicant, shall specifically describe the property involved
19 and shall state the facts upon which it is claimed such
20 reduction should be made. The department of revenue shall,
21 however, have the right to raise or lower the valuation of
22 all of one class of property in a county, as provided in the
23 preceding section."
