J Section 1. Section 16-1164, R.C.M. 1947, is amended to read as follows:

11 \*16-1164. Tax levy for support of museums. The board 12 of county commissioners of any county now owning, or hereafter acquiring any such museum or collection of 13 exhibits, may make an appropriation in its annual budget for 14 upkeep, care, maintenance, operation and support 15 the 16 thereof, and to meet and take care of such appropriation may 17 annually levy a tax of not to exceed one-half--(1/2) three 18 quarters (3/4) mill on each dollar of the taxable valuation of the property subject to taxation in the county, which 19 20 levy shall be made at the same time as other levies are made 21 for county and school purposes. The proceeds from the 22 collection of such levy shall be kept in a special fund by the county treasurer and used solely for the purpose for 23 24 which such levy was made."
