DESCRIPTION OF PROPOSED LEGISLATION:

Senate Bill 191 provides for an annual 1% increase in salaries of county sheriffs, undersheriffs, and deputy sheriffs.

ASSUMPTIONS:

- 1. There are 8 deputies, one undersheriff, and one sheriff per county.
- 2. 1974 taxable valuation and 1970 population figures are used for computation of present salaries.
- 3. Undersheriff salaries are 95% of sheriff salaries; deputy sheriff salaries are 90% of sheriff salaries.

Estimate is calculated for a 1% per year increase for each additional year of service after July 1, 1975. If the intent is to provide a longevity increase which is retroactive to every year after the first year of service, the cost will be significantly increased. For example, if the average number of years service for all persons affected under the bill is ten years as of the effective date, the cost would be ten times the amount shown.
