A BILL FOR AN ACT ENTITLED: "AN ACT TO AMEND SECTIONS 25-501 AND 93-303, R.C.M. 1947, TO IMPLEMENT THE EXECUTIVE AND JUDICIAL RECOMMENDATIONS OF THE MAJORITY REPORT OF THE MONTANA SALARY COMMISSION BY INCREASING THE COMPENSATION OF ELECTIVE OFFICIALS IN THE EXECUTIVE AND JUDICIAL BRANCHES; AND PROVIDING FOR AN EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 25-501, R.C.M. 1947, is amended to read as follows:

"25-501. Salaries of certain elected state officials. The annual salaries paid to certain elected officials of the state of Montana shall be as follows:

Governor.....	\$30,000	<u>39,000</u>
Lieutenant governor.....	\$20,500	<u>26,000</u>
Chief justice of the supreme court.....	\$20,000	<u>36,500</u>
Justices of the supreme court, each.....	\$27,000	<u>35,500</u>
Attorney general.....	\$25,000	<u>29,000</u>
State auditor.....	\$10,000	<u>21,500</u>
Superintendent of public instruction.....	\$20,000	<u>27,000</u>
Public service commissioners.....	\$10,000	<u>21,500</u>
State treasurer.....	\$10,000	<u>21,500</u>

Clerk of the supreme court.....~~\$14,000~~ 17,500."
Section 2. Section 93-303, R.C.M. 1947, is amended to read as follows:
"93-303. Salaries of district judges. The annual salary of each district judge shall be ~~twenty-five-thousand dollars-(~~\$25,000~~)~~ thirty thousand dollars (\$30,000)."
Section 3. This act is effective July 1, 1975.
