# FISCAL NOTE

for House Bill 51 pursuant to Chapter 53, Laws of Montana, 1965 - Thirty-Ninth Legislative Assembly.			
Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members			
of the Legislature upon request.			

#### DESCRIPTION OF PROPOSED LEGISLATION:

A proposal to create a state lottery with the proceeds to be returned to the local governments and providing that the proposed act be submitted to the electors of the state of Montana.

#### ASSUMPTIONS:

- 1. The only conceivable cost which the proposed legislation might impose during the 1978-79 biennium lies in printing the measure on the ballot for the General Election of November 1978. This cost will be absorbed in the general expenditures for that election.
- 2. Since no form for the lottery is suggested and implementation (if it receives a favorable vote by the people in the 1978 election) must await the 1979 session, any figures on administrative costs or revenues to local governments would be sheer speculation.

### TECHNICAL NOTE:

The formula for returning net proceeds of the lottery to local governments might be more clearly delineated (lines 13,14) because it is not clear whether a ticket sold in a city ought to be counted as being sold in the county as well.
