DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 135 will raise the amount that can be charged for handling brand security agreements filed with the Department of Livestock from \$2.00 to a maximum of \$15.00.

ASSUMPTIONS:

- 1. The volume of security agreements will remain constant at 5,650 per year.
- 2. The cost of filing each agreement will be \$8,00 through the biennium.
