In compliance with a written request received <u>February 8</u>, 19 <u>77</u>, there is hereby submitted a Fiscal Note for <u>House Bill 389</u> pursuant to Chapter 53, Laws of Montana, 1965 - Thirty-Ninth Legislative Assembly.

Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION OF PROPOSED LEGISLATION:

An act to impose a gross receipts assessment on all passenger tramway operators in Montana and providing an immediate effective date.

ASSUMPTIONS:

- 1. That normally the number of skier visits to Montana ski areas will exceed 700,000 per year.
- 2. That the average cost of a ski lift ticket will be \$7.00.
- 3. 1/4 of 1 percent will generate approximately \$12,500 per year for this earmarked revenue fund.
- 4. Income will vary yearly but should increase approximately 7.5% on an average (U.S. Forest Service data).

FISCAL IMPACT:

Revenue	\$12,500	\$13,437

NOTE: The purpose of these funds is to administer the Passenger Tramway Safety Act which has an executive budget recommendation of \$12,600 in FY78 and \$13,600 in FY79.
