10 Section 1. Section 75-6105.1, R.C.M. 1947, is amended

11 to read as follows:

12 W75-6105.1. Notification of nontenure teacher 13 re-election. (1) The trustees shall provide written notice to all nontenure teachers who have been re-elected by the 14 fifteenth day of April. Any nontenure teacher who does not 15 16 receive notice of re-election or termination shall be automatically re-elected for the ensuing school fiscal year. 17 Any nontenure teacher who receives notification of his 18 re-election for the ensuing school fiscal year shall provide 19 the trustees with his written acceptance of the conditions 20 of such re-election within twenty (20) days after the 21 receipt of the notice of re-election. Failure to so notify 22 the trustees within twenty (20) days may be considered 23 nonacceptance of the tendered position. The provisions of 24 this section shall not apply to cases in which a nontenure 25

teacher is terminated when the financial condition of the school district requires a reduction in the number of teachers employed and the reason for the termination is to reduce the number of teachers employed.

5 (2) When the trustees notify a nontenure teacher of ĸ termination, the teacher may within ton (10) days after recoipt of such notice make written request of the trustees for a statement in writing of the reasons for termination of employment. Within ten (10) -days -after receipt - of the 10 request the trustees shall furnish such statement to the 11 teacher. Any nontenure teacher who receives a notice of 12 termination or nonrenewal may request, in writing, within 10 13 days after the receipt of such notice, a written statement 14 declaring clearly and explicitly the specific reason for the 15 termination of his services. The trustees shall supply this 16 statement within 10 days after the request is received. 17 Within-10-days after receiving a statement of reasons for 18 his termination, a nontenured teacher may request, in 19 writing, a hearing before the trustees to reconsider their 20 termination action. Bithin 10 days ofter the receipt of -a 21 request for a hearing, the trustees shall conduct the 22 hearing and reconsider their termination action."

24 25 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HONTANA:

Section 1. Section 75-6105.1, R.C.M. 1947, is amended 10

11 to read as follows:

> "75-6105.1. Notification of nontenure teacher re-election. (1) The trustees shall provide written notice to all nontenure teachers who have been re-elected by the fifteenth day of April. Any nontenure teacher who does not receive notice of re-election or termination shall be automatically re-elected for the ensuing school fiscal year. Any nontenure teacher who receives notification of his re-election for the ensuing school fiscal year shall provide the trustees with his written acceptance of the conditions of such re-election within twenty (20) days after the receipt of the notice of re-election. Pailure to so notify the trustees within twenty (20) days may be considered nonacceptance of the tendered position. The provisions of

this section shall not apply to cases in which a nontenure

teacher is terminated when the financial condition of the school district requires a reduction in the number of 3 teachers employed and the reason for the termination is to reduce the number of teachers employed.

5 (2) When the trustees notify a nontenure teacher of termination, the teacher may within ten (10) days after 5 7 receipt of such notice make written request of the trustees 8 for a statement in writing of the reasons for termination of 9 employment. Within ten (10) days after receipt of the 10 request the trustees shall furnish such statement to the 11 teacher. Any nontenure teacher who receives a notice of 12 termination or nonrenewal may request, in writing, within 10 13 days after the receipt of such notice, a written statement 14 declaring clearly and explicitly the specific reason for the 15 termination of his services. The trustees shall supply this statement within 10 days after the request is received. 16 17 Within 19 days after reseiving a statement of reacons for 18 his termination, a montenured teacher may request, in 19 writing, a hearing before the trustees to reconsider their 20 termination action. Within 10 days after the reseipt of a 21 request for a hearing, the trustees chall conduct the 22 hearing and reconsider their termination action."
