DESCRIPTION

This bill permits a licensed wholesaler, subjobber, retailer, or vendor to sell cigarettes to a resident or nonresident person, wholesaler, subjobber, retailer, or vendor who is exempt from state cigarette taxation provisions.

ASSUMPTION

There is no way to give a precise estimate of the fiscal impact of this bill. It is felt that in the long run that this bill would make unstamped cigarettes easier to obtain. This could cause a reduction of the cigarette tax revenues.
