Section 1. Section 94-8-221, R.C.M. 1947, is amended
to read as follows:

13 "94-8-221. Firearms -- air rifles -- use of by 14 children under the age of fourteen years prohibited. (1) It 15 shall--be is unlawful for any parent, quardian, or other persony having the charge or custody of any minor child 16 under the age of fourteen 14 years, to permit such minor 17 18 child to carry or use any firearms of any description, 19 loaded with powder and lead, in publicy except when such 20 child is in the company of such parent or guardian or under the supervision of a qualified firearms safety instructory 21 22 who has been duly authorized by such parent or quardian. 23
