Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION

This bill repeals sections 84-6301 through 84-6308, R.C.M. 1947, relating to the importer's tax on gasoline purchased outside the state and used in the state.

ASSUMPTION

No projections on revenues or expenditures have been made concerning the importer's tax on gasoline. However, historical data may illustrate the potential impact of this bill. In FY 76 revenues from this tax amounted to \$11,463 and administrative costs were \$7,709. In FY 75 revenues were \$12,189.47 and costs were \$8,971. It appears that the net loss which would result if this bill were enacted would be approximately \$4,000 annually.
