"40-2819. Serving process — time to plead.

(1) Duplicate copies of legal process against an insurer for whom the commissioner is attorney pursuant to section 40-2818, shall be served upon the commissioner, or upon his deputy or other person in charge of his office during his absence. At the time of service the plaintiff shall pay to the commissioner three-dollars-(\$3) \$10, taxable as costs in the action.
