BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Report to state fire marshal bureau. (1) Each of the following institutions or facilities having the charge or custody of a person convicted of arson, or of a person acquitted of arson on the ground of mental disease or defect, shall give written notification to the fire marshal bureau of the department of justice whenever such a person is admitted or released by it:

- (a) Warm Springs state hospital;
- (b) state prison;
- (c) Mountain View school;
- (d) Pine Hills school;
- (e) Swan River youth forest camp;
- (f) any county or city detention facility.

(2) The notification shall disclose:

- (a) the name of the person;
