9	Section 1. State library to furnish basic library

13	as provided by part 3 of this chapter.				
14	(2) A free public library need not be a member of a				
15	library federation or library metwork in order to receive				
16	the following services from the state library:				
17	(a) the lending of books and reference materials;

20	(c) library assistance and information services.

DESCRIPTION OF PROPOSED LEGISLATION:

HB 35 mandates the State Library to provide basic library services to free public libraries in Montana.

ASSUMPTIONS:

- 1. Currently the lending of books and reference materials to Montana residents is done through the six federation headquarters libraries. In the past fiscal year, at least 55,184 interlibrary loans were handled by the six libraries. It is assumed that these transactions would have to be transferred to Montana State Library under HB 35.
- 2. A total of 25,000 requests from state agencies were handled last year by Montana State Library. The additional transfer of services required by HB 35 would mean that Montana State Library would have to handle triple the number of requests it presently handles. In the federation headquarters libraries, 12 FTEs are needed to provide these services. Reference, interlibrary loan, documents and circulation staffs would have to be increased at Montana State Library by 12 FTEs 5 professional librarians and 7 clerical staff members.
- 3. Large increases in the State Library book budget will be required.
