
In compliance with a written request received ^{MARCH} ~~February~~ 2, 1979, there is hereby submitted a Fiscal Note for House Bill 191 pursuant to Chapter 53, Laws of Montana, 1965 - Thirty-Ninth Legislative Assembly. Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION:

This proposed bill provides financial support for the Montana University system.

FISCAL IMPACT:

This legislation provides for a levy of up to 6 mills upon the taxable value of all real and personal property in the state subject to taxation to support the Montana University System. The 6 mills is anticipated to generate \$9.9 million in FY 80 and \$10.4 million in FY 81. The revenues are included in the Executive Budget.
