10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11 Section 1. Section 16-3-304, MCA, is amended to read:
12 "16-3-304. Closing hours for licensed retail
13 establishments. All licensed establishments wherein
14 alcoholic beverages are sold, offered for sale, or given
15 away at retail shall be closed each day between 2 a.m. and 8
16 a.m. ~~provided, however, that when any municipal~~
17 ~~incorporation has by ordinance further restricted the hours~~
18 ~~of sale of alcoholic beverages, then the sale of alcoholic~~
19 ~~beverages is prohibited within the limits of any such city~~
20 ~~or town during the time such sale is prohibited by this code~~
21 ~~and in addition thereto during the hours that it is~~
22 ~~prohibited by such ordinance and may be open for business at~~
23 all other times. During such hours all persons except the
24 owner and employees of such licensed establishments shall be
25 excluded therefrom except as provided in 16-3-305."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
