DESCRIPTION

This bill provides for a prorated tax on mobile homes leaving the state.

AFFECT ON LOCAL GOVERNMENT

No data are available on the number of mobile homes effected by this legislation; however, it is felt that the number is fairly small. Therefore, the fiscal impact to local governments should not be that great.
