In compliance with a written request received February 6, 1979, there is hereby submitted a Fiscal Note for House Bill 418 pursuant to Chapter 53, Laws of Montana, 1965 - Thirty-Ninth Legislative Assembly. Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

#### DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 418 would increase payments to day care facilities by \$1.00 per day through December 31, 1980, and by \$2.00 per day thereafter.

#### **ASSUMPTIONS:**

- 1. The present average daily rate paid to day care facilities is \$4.50.
- 2. The rate increase for FY 80 is 22 percent; for FY 81 is 33 percent.
- 3. The rate increase for the thirty percent of day care for AFDC recipients who are in a training program and not working would be paid with Title IV-A federal matching funds. All the remaining day care increases, those for working AFDC recipients, WIN recipients, and CWS (child protective services), would be paid 100% General Fund.
