The board is authorized to issue and sell long-range building program bonds in an amount not exceeding ~~\$2.5 million~~ \$10,035,000, over and above the amount of the long-range building program bonds outstanding January 1, ~~1973~~ 1979, upon the conditions and in the manner stated in this part. The board is also authorized to issue and sell long-range building program bonds in such amount as may be required to provide funds for the payment or redemption of outstanding bonds as contemplated in 17-5-402 and 17-5-407.
