 4 A BILL FOR AN ACT ENTITLED: "AN ACT TO INCREASE FROM  
 5 \$15,000 TO \$50,000 THE MAXIMUM AMOUNT WHICH MAY BE RAISED BY  
 6 THE COUNTY BY TAXATION TO FINANCE FIRE CONTROL ACTIVITIES;  
 7 AMENDING SECTION 7-33-2209, MCA; AND PROVIDING AN EFFECTIVE

 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11 Section 1. Section 7-33-2209, MCA, is amended to read:

12 "7-33-2209. Finance of fire control activities. (1)

13 The county governing body is authorized to appropriate funds  
 14 for the purchase, care, and maintenance of firefighting  
 15 equipment or for the payment of wages in prevention,  
 16 detection, and suppression of fires.

17 (2) If the general fund is budgeted to the full limit,  
 18 the county governing body may, at any time fixed by law for  
 19 levy and assessment of taxes, levy a tax at such rate as in  
 20 their judgment will be necessary to raise such needed sum,  
 21 not to exceed ~~\$15,000~~ \$50,000."

22 Section 2. Effective date. This act is effective on  
 23 passage and approval.
