In compliance with a written request received February 5, 1979, there is hereby submitted a Fiscal Note for House Bill 508 pursuant to Chapter 53, Laws of Montana, 1965 - Thirty-Ninth Legislative Assembly. Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 508 is an act to increase District Judges salaries from the current level of \$35,000/yr to \$37,500/yr in FY 1980 and \$40,000/yr in FY 1981.

ASSUMPTIONS:

- 1) The number of District Judges remains at the current level of 31 for the 80-81 Biennium.
- 2) The states share of benefits for District Judges remains at the present level of approximately 10%.

FISCAL IMPACT:
