BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Statistics on domestic violence and spouse abuse. The department of social and rehabilitation services shall establish and administer a program to collect. maintain, and analyze statistics relating to domestic violence and spouse abuse in the state.

Section 2. Agencies and officials information to department. (1) The department of social and rehabilitation services is the lead agency for collection of data on domestic violence and spouse abuse.
