Section 1. Section 7-4-2821, MCA, is amended to read:

"7-4-2821. Fees of county surveyor. ~~The county surveyor is entitled to receive and collect for his own use the following fees:~~

~~(1) for copies and certificates, 20 cents per folio;~~

~~(2) for a copy of any plot of survey, \$2;~~

~~(3) for services in making a survey required by any court or made for the county by order of the board of county commissioners, the sum of \$12 for each working day with travel expenses while away from home in the performance of the duties of his office, to be paid out of the contingent fund;~~

~~(4) for expenses of chainmen and workers, if furnished by the surveyor, not to exceed \$8 per day. The board of county commissioners shall set the county surveyor's fees by resolution.~~
