In compliance with a written request received February 13, 1979, there is hereby submitted a Fiscal Note for House Bill 688 pursuant to Chapter 53, Laws of Montana, 1965 - Thirty-Ninth Legislative Assembly. Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION OF PROPOSED LEGISLATION:

A proposal to enable the PSC to require and receive an additional sum from the public utilities, motor carriers and railroads to pay the costs of publishing legal notices.

ASSUMPTION:

The Public Service Commission (PSC) will retain jurisdiction over the present number of motor carriers, railroads and public utilities and will receive approximately the same number of applications.
