A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA CONSENTING TO THE ACQUISITION. CONSTRUCTION. EQUIPMENT, AND FINANCING OF IMPROVEMENTS TO THE PHYSICAL EDUCATION. ATHLETIC. AND RECREATIONAL FACILITIES AND STUDENT UNION BUILDING AT HONTANA STATE UNIVERSITY.

BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA:

That, under the provisions of Sections 18-2-102 and 20-25-302. MCA, and subject to the availability of funds other than the appropriated funds from regular state revenues for state operations, the Legislature consents to a capital construction program at Montana State University, Bozeman, Montana, consisting of the acquisition, construction, and equipment of improvements to the physical education, athletic, and recreational facilities and further consents to the financing of this project by the Board of Regents, without legislative appropriation of money, from gifts, grants, fees, and earnings available to the Board of Regents and from the issuance of revenue bonds by the Board of Regents in accordance with Section 20-25-402, MCA,

provided that the principal amount of the revenue bonds does

Sections 18-2-102 and 20-25-302, MCA, and subject to the availability of funds other than the appropriated funds from regular state revenues for state operations, the Legislature consents to a capital construction program at Montana State University, Bozeman, Montana, consisting of the acquisition, construction, and equipment of improvements to the student union building, and further consents to the financing of this project by the Board of Regents, without legislative appropriation of money, from gifts, grants, fees, and earnings available to the Board of Regents and from the issuance of revenue bonds by the Board of Regents in accordance with Section 20-25-402, MCA, provided that the principal amount of the revenue bonds does not exceed \$5,000,000.
