DESCRIPTION:

Senate Bill 26 is an act to increase the fee for issuing duplicate fish and game licenses in order to make it more commensurate with the administrative costs involved. It proposes to increase the fee from \$1.00 to \$3.00.

ASSUMPTIONS:

- It is assumed that the administrative costs associated with replacing original fish and game licenses is currently about \$3.00 per license.
- 2. It is also assumed that the proposed fee increase will slightly reduce the number of replacement requests.
