DESCRIPTION

An act to clarify the fees applicable to certain vehicles.

FISCAL IMPACT

It is felt that this proposal would have an insignificant fiscal impact and affect on expenditures.

TECHNICAL NOTE

There is a possible need to clarify the definitions and distinctions between travel trailers and house trailers. Both have the same physical description but the difference is a matter of its use. (See 15-24-201 & 61-1-131 MCA)

Description of Proposed Legislation

An act to clarify the fees applicable to certain vehicles.

Fiscal Impact

The Department of Highways has estimated that fees presently collected for travel trailers will not be collected with passage of this measure. This will result in lost revenues of about \$204,000 for each of the next two years or \$408,000 over the biennium.

The money is presently put into the Highway Earmarked Revenue Account.
