DESCRIPTION OF PROPOSED LEGISLATION

House Bill 72 is proposed amendment to Section 13-10-401 changing the date of the primary election from June to September.

1. Current staff can administer proposed legislation.
2. Act would be effective before 1982 primary.
3. Costs are based on same basis as FY 1982 and 1983 biennium budget.



Local Impact

Proposed legislation would adversely affect county election administrators by compaction of workload requiring additional personnel and by increasing equipment costs in those areas using automatic voting devices other than CES-Volmatic. This letter impact occurs in the case of potential recounts which would preclude unsealing and reprogramming of election devices. Representative impact estimates were obtained from various counties. Estimates ranged from \$10,000 to \$50,000 per annum.
