In compliance with a written request received
for House Bill 271 pursuant to Title 5, Chapter 4, Part 2 of the Montana Code Annotated (MCA).
Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members
of the Legislature upon request.

Description of Proposed Legislation

This bill provides for a disability retirement allowance to ba paid to an active volunteer fireman who becomes totally and permanently disabled. Also provides for review of the disability and concellation of allowances.

Fiscal Impact

The number of volunteers that will become totally and permanently disabled cannot be determined. This will cause some fiscal impact; however, it cannot be calculated

Comment

Whatever cost associated with this measure will be nullified by the fact that the benefit payments cannot exceed 95% of the previous year's growth which guarantees a growth of 5% a year to the fund. If there is not sufficient growth in the fund to pay the maximum benefits, then all benefits are reduced proportionately. Therefore, the fiscal impact would be to the benefit recipients as a whole if reduced benefits were required.
