# Description of Proposed Legislation

An act requiring the payment of all unclaimed winning ticket money from parimutual betting to the Board of Regents of Higher Education to provide financial aid to certain students; amending Section 23-4-305, MCA.

#### Assumptions

- Unclaimed winning tickets money collected in FY 1979 \$18,665.71; FY 1980 -\$22,859.50. Estimate for FY 1982 - \$23,000; FY 1983 - \$24,000. This revenue is deposited in the Board of Horse Racing earmarked account and used to fund its operations.
- 2. Total Board of Horse Racing revenue from all sources was:

FY 1979 - \$130,355.27 FY 1980 - \$139,424.56

Estimate for FY 1982 - \$140,000 and FY 1983 - \$142,000
