Description of Proposed Legislation

House Bill 309 requires annual notices of security agreements and annual renewal of assignments of security interests to be filed with the Department of Livestock.

Fiscal Impact

A dollar estimate cannot be made for House Bill 309.

Comments

The Department of Livestock is in the process of computerizing the filing and noticing of security agreements and satisfactions.

Section 81-8-304, MCA, provides that the Department of Livestock shall charge a fee for filing and listing the notices of security agreements and satisfactions for each recorded brand listed based on actual cost to the department.

Until the computerizing process is complete and in actual use, we cannot establish costs or revenue effects resulting from House Bill 309.

Section 1. Section 81-8-301. MCA, is amended to read:

"81-8-301. Notices of security agreements _____renewals

___assignments. (1) The department of livestock shall accept
and file notices of security agreements, renewals,
assignments, and satisfactions covering livestock owned by a
person, firm, corporation, or association and bearing its
recorded brand and shall list the notices on the official
records of marks and brands kept by it. The department shall
also-list TRANSFER A CDPY OF the notices in-the--offices--of
the---stock---inspectors--employed--by--the--department--ond
stationed-at AND THEIR ACCOMPANYING BRANDS TO the central
livestock markets where--records--are--kept--of--marks-and
brands. All forms on which the notices are given shall be

prescribed by the department and furnished by the secured
party who gives the notice. A livestock market to which
livestock is snipped may not be held liable to any secured
party for the proceeds of livestock sold through the
livestock market by the debtor unless notice of the security
agreement is filed <u>AND A COPY IS TRANSFERRED</u> as hereinbefore
provided. <u>THE DEPARTMENT OF LIVESTOCK MAY NOT BE HELD LIABLE</u>
