16 published in a newspaper:

17 (a) at the adjournment of each session of the board, a  
18 ~~complete list of all claims ordered paid for all purposes,~~  
19 ~~showing the name, purpose, and amount,~~ the expenditure  
20 totals for each budget category, the total expended from  
21 cash funds for the budget year, and a fair summary of the  
22 minutes and records of all of its proceedings;

23 (b) annually, the county clerk's annual statement of  
24 the financial condition of the county.

25 (2) Publication of such minutes and records of

1 proceedings must be made within 21 days after the  
2 adjournment of the session. Publication of the financial  
3 statement must be made within 30 days after the presentation  
4 of the same to the board. The board shall not allow or order
