4 A BILL FOR AN ACT ENTITLED: "AN ACT TO PROVIDE THAT A STATE
5 GAME BIRD LICENSE IS REQUIRED TO HUNT UPLAND GAME BIRDS IN
6 MONTANA AND THAT, IN ADDITION TO ANY FEDERAL REQUIREMENTS,
7 ONLY A WILDLIFE CONSERVATION LICENSE IS REQUIRED TO HUNT
8 MIGRATORY GAME BIRDS; AMENDING SECTIONS 87-2-401 AND
9 87-2-402, MCA."

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12 Section 1. Section 87-2-401, MCA, is amended to read:
13 "87-2-401. ~~Class---A-1---resident~~ Resident game bird
14 ~~license~~ licenses. (1) Except as otherwise provided, a
15 resident, as defined by 87-2-102, who is 12 years of age or
16 older may, upon payment of a fee of \$4, receive a Class A-1
17 license which will entitle the holder to pursue, hunt,
18 shoot, and kill upland game birds and possess the carcasses
19 of upland game birds as authorized by department rules.

20 ~~(2) A resident, as defined by 87-2-102, who is 12~~
21 ~~years of age or older may pursue, hunt, shoot, and kill~~
22 ~~migratory game birds and possess the carcasses of migratory~~
23 ~~game birds as authorized by the department rules upon:~~

- 24 ~~(a) purchasing a wildlife conservation license; and~~
25 ~~(b) complying with applicable federal requirements."~~

1 Section 2. Section 87-2-402, MCA, is amended to read:
2 "87-2-402. ~~Class--B-1--nonresident~~ Nonresident game
3 bird ~~license~~ licenses. (1) Except as otherwise provided in
4 this chapter, a person not a resident, as defined in
5 87-2-102, but who is 12 years of age or older, upon payment
6 of a fee of \$30 may receive a Class B-1 license which shall
7 entitle the holder thereof to pursue, hunt, shoot, and kill
8 upland game birds and possess the carcasses of upland game
9 birds as authorized by department rules.

10 ~~(2) A person not a resident, as defined in 87-2-102,~~
11 ~~but who is 12 years of age or older may pursue, hunt, shoot,~~
12 ~~and kill migratory game birds and possess the carcasses of~~
13 ~~migratory game birds as authorized by department rules upon:~~
