14 administrative code committee may by a vote of two-thirds of  
15 its members repeal any agency rule or any part of an agency  
16 rule, effective upon notification of the agency.

17 Section 2. Effective date. If approved by the  
18 electorate, this amendment is effective January 1, 1983.

19 Section 3. Submission to electors. This amendment  
20 shall be submitted to the electors of the state of Montana  
21 at the general election to be held in November, 1982, by  
22 printing on the ballot the full title of this act and the  
23 following:
