BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 5-2-301, MCA, is amended to read:

"5-2-301. Compensation and expenses for members while
in session. (1) Legislators are entitled to a salary
commensurate to that of the daily rate of a grade 8, step 2
classified state employee, for those days during which the
legislature is in session. The president of the senate and
the speaker of the house shall receive an additional \$5 a
day in salary for those days during which the legislature is
in session.

- (2) tegislators Except as provided in subsection (5):

 legislators are entitled to \$40 a day, 7 days a week, during
 a legislative session, as reimbursement for expenses
 incurred in attending a session. Expense payments shall stop
 when the legislature recesses for more than 3 days and shall
 resume when the legislature reconvenes.
 - (3) Lagislators are entitled to a mileage allowance as

In compliance with a written request received <u>February 4</u> , 19 81 , there is hereby submitted a Fiscal Note
for House Bill 608 pursuant to Title 5, Chapter 4, Part 2 of the Montana Code Annotated (MCA).
Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members
of the Legislature upon request.

DESCRIPTION OF PROPOSED LEGISLATION:

House Bill No. 608 would remove the entitlement for payment of expenses to legislators who live at home during the session and would allow mileage allowances to be paid to those legislators who live at home but outside the City of Helena.

ASSUMPTIONS:

- 1. Two legislators would qualify for round trip mileage of approxemately 50 miles total.
- 2. Seven legislators would lose entitlement to expense reimbursement.
- 3. The expense allowance would remain \$45 in Fy 1983 while the travel allowance would by \$0.26/mile.

FISCAL IMPACT:

The expense allowance payments would be reduced by \$33,075 while the round trip allowance payments would increase by \$1,170. The net saving to the General Fund would be \$31,905.
