HOUSE SILL NO. 669

INTRODUCED BY OND PROPERTY AND CANE COMMISSION; AMENDING TO SECTION 87-1-304, MCA."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 87-1-304. MCA. is amended to read: #87-1-304. Fixing of seasons and bag and possession limits. (1) The commission may fix seasons, bag limits, possession limits, and season limits; open or close, shorten or lengthen seasons on any species of game, bird, fish, or fur-bearing animal as defined by 87-2-101; and declare areas open to the hunting of deer, antelope, elk, moose, sheep, and boat by bow and arrow permit holders and designate times when only bow and arrows may be used to hunt deer, antelope, elk, moose, sheep, and qoat in those areas. Opening days for came animal seasons may be set on dates determined by the commission in its discretion, but those opening days must be Saturdays. It The commission may declare areas open to deer bunting where shotguns only may be used to hunt or kill deer. It may declare areas open to special license holders only and issue special licenses in a limited number when it

determines, after proper investigation, that such a season is necessary to assure the maintenance of an adequate supply of game birds, fish, animals, or fur-bearing animals. It may declare a special season and issue special licenses when dame birds or animals or fur-bearing animals are causing damage to private property or when written complaint of such damage has been filed with the commission by the owner of that property. In determining to whom those licenses shall be issued, it may, when more applications are received than 10 the number of animals to be killed, award permits to those 11 chosen under a drawing system. The procedures used for 12 awarding the permits from the drawing system shall be 13 determined by the commission.

(?) The commission may adopt rules governing the use of livestock and vehicles by archers during special archery seasons.
