- 15 *23-3-201. Jurisdiction over boxing, sparring, and
- 16 wrestling matches -- licenses -- application for license.
- 17 (1) The board has the sole direction, management, control,
- 18 and jurisdiction over boxing, sparring, and wrestling
- 19 matches and exhibitions conducted, held, or given within
- 20 this state by a club, corporation, or association. No
- 21 boxing, sparring, or wrestling match or exhibition may be
- 22 conducted, held, or given within this state except when
- 23 licensed in accordance with this part.
- 24 (2) The board may grant or revoke, subject to 37-1-101
- 25 and 37-1-102, a license to conduct, hold, or give boxing,

sparring, and wrestling matches and exhibitions to a club, corporation, or association which, if it is an amateur athletic association, may be incorporated or organized under rules adopted by the board.

- (3) This part does not apply to or prohibit amateur boxing or wrestling exhibitions conducted in or by organized amateur clubs, schools, and qymnasiums.
 - (4) A license is subject to rules the board makes.
 - (5) An application for a license shall be in writing and addressed to the department and verified by an officer of the club, corporation, or association on whose behalf the application is made. It shall contain facts which show the applicant entitled to receive a license and other facts and recitals the board by rule requires to be shown.
 - (6) No boxers wrestlers officials or ring attendant may participate in a professional boxings sparrings or wrestling match within the state unless licensed under this sections. The board may charge a nonrefundable fees not to exceed \$25s for such a license and may prescribe an application form containing such information it considers necessary. The board may adopt rules governing licensees to ensure compliance with the provisions of this chapter and to provide for physical and health standards and other qualifications as it considers necessarys A violation of the rules is grounds for denials suspensions or revocation of
