In compliance with a written request received February 18, 19 81, there is hereby submitted a Fiscal Note for HB 750 pursuant to Title 5, Chapter 4, Part 2 of the Montana Code Annotated (MCA).

Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

Description of Proposed Legislation:

A proposal to require every insurer of workers' compensation to notify each employer annually of all benefits that are ongoing and being charged against the employer's account.

Assumption:


- 1.) The proposed notifications would include all accidents and wage loss claims of all active employers insured with the State Compensation Insurance Fund.
- 2.) 20% of the enrolled employers have the most accidents, and computer runs for them will cost \$8.00 each. Computer runs for the remainder of the employers enrolled will cost \$3.00 each.
- 3.) Although the proposal will also affect private insurance carriers, no attempt has been made to gather that cost data.
