In compliance with a written request received February 20, 19 81, there is hereby submitted a Fiscal Note for House Bill 812 pursuant to Title 5, Chapter 4, Part 2 of the Montana Code Annotated (MCA). Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

Description of Proposed Legislation

This proposal would repeal expanded day care assistance and its sliding scale method of payment.

Fiscal Impact

Sliding scale day care was estimated to have cost the following amounts, which are all a requirement of the state general fund:

Day Care Sliding Scale	\$414,374	\$493,644	\$918,018

Comment

The recommendations of the appropriations subcommittee for Human Services are based on passage of this bill. If passage does not occur, the appropriation of the Department of Social and Rehabilitation Services would need to be increased by the above amounts.
