BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Division to publicize permit.

(1) The division of motor vehicles shall publicize the provisions of 49-4-301 through 49-4-305 in a manner designed to inform those eligible for a special parking permit.

(2) The division of motor vehicles shall budget sufficient funds to accomplish the requirements of subsection (1).

Section 2. Codification instruction. Section 1 is intended to be codified as an integral part of Title 49, chapter 4, part 3, and the provisions of Title 49, chapter 4, part 3, apply to section 1.
