Section 1. Section 17-7-112, MCA, is amended to read:

(1) Except as provided in this subsection, it~~ It shall be the duty of each department, agency, and office to submit information requested by the budget director on or before ~~August 15~~ September 1 in the even year preceding the convening of the legislature. ~~The--Montana-university-system--the-department-of-institutions--and-the-department-of-highways--shall-submit such-information-on-or-before-September-1-of-such-years~~

(2) If any department, institution, or agency shall fail to present such requested information within the time herein specified, the budget director shall note that fact in the budget submitted to the governor and the budget director shall prepare a budget request on behalf of such department, institution, or agency, based upon his studies of the operations, plans, and needs thereof."
