BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 72-15-301, MCA, is amended to read:

"72-15-301. Compensation of public administrator. (1)  
The public administrator shall receive and collect for his  
own use as full compensation for his services, including  
attorney's fees one and one-half times the amounts  
applicable amount provided for in 72-3-631 and 72-3-633.

(2) If the public administrator employs an attorney to  
represent him in a decedent's estate, the compensation of  
the attorney shall be paid by the estate and may not exceed  
the compensation allowed under 72-3-633."

Section 2. Applicability. This act applies to estates  
of decedents dying after the effective date of this act.
