WHEREAS, the sunset law, sections 2-8-103 and 2-8-112, MCA, terminates the Board of Athletics and requires a performance evaluation of the Board by the Legislative Audit Committee; and

WHEREAS, as a result of the performance evaluation, the Legislative Audit Committee recommends that the Board of Athletics be abolished.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Repealer. Sections 2-15-1661, 23-3-101 through 23-3-103, and 23-3-201 through 23-3-209, MCA, are repealed.
