9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10 Section 1. Section 5-2-302, MCA, is amended to read:

11 "5-2-302. Compensation and expenses when legislature
 12 not in session. (1) When the legislature is not in session,
 13 members of the legislative council, legislative
 14 subcommittees, and select and interim committees, while
 15 engaged in committee business authorized by the legislative
 16 council, are entitled to:

17 (1)(a) a mileage allowance as provided in 2-18-503;

18 (1)(b) expenses as provided in 2-18-501 and 2-18-502;

19 and

20 (1)(c) a salary equal to one-fourth the daily rate of
 21 a grade 8, step 1 classified state employee, for every 6
 22 hours or fraction thereof spent away from home on committee
 23 business.
