INTRODUCED BILL
In compliance with a written request received January 6,_, 19 , there is hereby submitted a Fiscal Note for House Bill 48 pursuant to 'Title 5, Chapter 4, Part 2 of the Montana Code Annotated (MCA). Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

## DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 48 amends Section 39-73-109, making the eligibility requirements and benefit payments for surviving spouses of silicosis victims uniform and eliminates the $\$ 6800$ taxable income limitation.

## ASSUMPTIONS:

1.) That benefit payments for silicotics will remain at $\$ 200$ per month.
2.) That the number of spouses now receiving reduced and limited benefits will remain the same or decrease.
3.) That the administrative expense involved in making this change will be negligible.
4.) That a maximum of 20 spouses will apply and receive benefits who are ineligible because of the $\$ 6800$ taxable income limitation under current law.
